

## INTERLOCAL AGREEMENT

This Interlocal Agreement, ("The Agreement"), is entered into by and between Leon County, ("The County"), a political subdivision of the State of Texas; and the cities of Centerville, Leon, Normangee, Marquez, Jewett, Buffalo, and Oakwood, ("The Cities"), also political subdivisions of the State of Texas; and executed in accordance with the provisions of the Interlocal Cooperation Act, Chapter 791, Texas Government Code.

WHEREAS, on or about the 27<sup>th</sup> day of May, 2003, "The County" adopted rules regulating on-site sewage facilities in Leon County, Texas, (a copy of which is attached hereto); and

WHEREAS, both "The County" and "The Cities" desire to provide the residents of Leon County, Texas with a system of orderly, adequate public health protection, and to minimize environmental pollution;

NOW THEREFORE, "The County" and "The Cities" hereby Agree as follows:

1. Each of "The Cities" agree to waive and grant to "The County" exclusive jurisdiction to enforce its rules regulating on-site sewage facilities within each of "The Cities" territorial limits,(both city limits and extraterritorial);
2. "The County" agrees to implement and enforce its rules regulating on-site sewage facilities within each of "The Cities" territorial limits, (city limits and extraterritorial);
3. "The Agreement" may not be modified or amended except by written agreement duly executed by both parties;
4. "The Agreement" has been duly and properly approved by each entities governing body and thereby constitutes a binding obligation on each entity; and
5. "The Agreement" shall become effective as of the date each entity's governing body signs below.

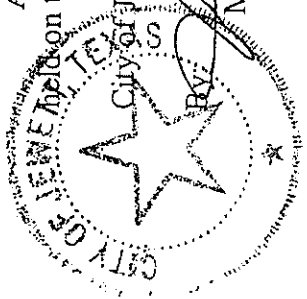
