AN ORDINANCE RELATING TO SPEED ZONES WHICH SPECIFICALLY DESIGNATES ADDITIONAL AREAS IN THE CITY OF JEWETT IN WHICH RATES OF SPEED OF THIRTY (30) MILES PER HOUR OR MORE ARE AUTHORIZED; RESCINDING ALL PARTS OF ORDINANCES IN CONFLICT HERewith; AND DECLARING THAT ATTENDANT FACTS NECESSITATE IMMEDIATE ACTION.

BE IT ORDAINED BY THE CITY OF JEWETT:

SECTION I. That any and all ordinances or parts of ordinances relating to speed zones on FM 39 in the City of JEWETT are hereby rescinded, and the following are additional specifically designated areas in which a rate of speed of thirty (30) miles per hour or more is authorized.

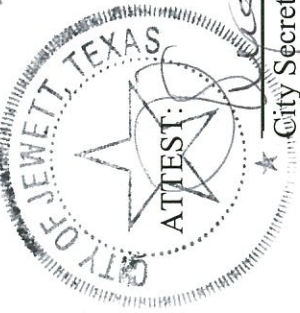
- A.) FM 39, for traffic moving in a southerly direction from the north Jewett city limit for 0.210 miles, the speed limit shall be fifty-five (55) miles per hour. For the next 0.439 miles, the speed limit shall be forty-five (45) miles per hour. For the next 0.310 miles, the speed limit shall be fifty-five (55) miles per hour. For the next 0.161 miles to the south Jewett city limit, the speed limit shall be sixty (60) miles per hour.
- B.) FM 39, for traffic moving in a northerly direction from the south Jewett city limit for 0.161 miles, the speed limit shall be sixty (60) miles per hour. For the next 0.310 miles, the speed limit shall be fifty-five (55) miles per hour. For the next 0.439 miles, the speed limit shall be forty-five (45) miles per hour. For the next 0.210 miles to the north Jewett city limit, the speed limit shall be fifty-five (55) miles per hour.




