

AN ORDINANCE ESTABLISHING RULES, REGULATIONS AND PENALTIES FOR THE HERMAN F. HAMMOND CITY PARK; REPEALING ALL PREVIOUSLY ENACTED ORDINANCES OR RESOLUTIONS INCONSISTENT HERewith; PROVIDING AN EFFECTIVE DATE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF JEWETT, TEXAS:

SECTION 1. RULES AND REGULATIONS

1. PUBLIC ACCESS. THE CITY PARK'S PUBLIC ACCESS HOURS WILL BE SET BY THE PARKS COMMITTEE AND MAY BE SUBJECT TO SEASONAL CHANGE. EXTENDED HOURS CAN BE AUTHORIZED FOR SPECIAL EVENTS BY CITY PERMIT.
2. VANDALISM. NO PERSON SHALL CUT, BREAK, SCRATCH, MARK OR IN ANY WAY INJURE OR DEFACE ANY BUILDING, FENCE, LAMPPOST, FLAGPOLE, CONSTRUCTION, IMPROVEMENT, FACILITY OR ANY OTHER FEATURE OR PROPERTY UPON OR WITHIN THE PARK.
3. MOTORIZED VEHICLES. ALL MOTORIZED VEHICLES ARE PROHIBITED WITHIN THE PARK EXCEPT IN DESIGNATED PARKING LOTS. WHEEL-CHAIRS AND ELECTRIC SCOOTERS USED BY PERSONS WITH A DISABILITY ARE EXEMPT.
4. CAMPING. CAMPING IS PROHIBITED EXCEPT BY CITY PERMIT AVAILABLE TO SPONSORED YOUTH ACTIVITIES.
5. FIRES. FIRES ARE PROHIBITED EXCEPT IN CONTAINERIZED COOKING DEVICES OR BY CITY PERMIT.
6. FIREARMS. USE AND POSSESSION OF ANY FIREARM, BOW AND ARROW, SLING SHOT, AIR RIFLE OR PISTOLS ARE PROHIBITED. ORGANIZED BOW & ARROW OR AIR RIFLE EVENTS CAN BE AUTHORIZED BY CITY PERMIT.
5. FIREWORKS & EXPLOSIVES. FIREWORKS & EXPLOSIVES ARE PROHIBITED EXCEPT BY CITY PERMIT FOR ORGANIZED EVENTS.
6. ALCOHOLIC BEVERAGES. ALCOHOLIC BEVERAGES ARE PROHIBITED IN THE PARK EXCEPT BY CITY PERMIT FOR ORGANIZED EVENTS. AN ARMED SECURITY GUARD MUST BE PROVIDED BY THE SPONSOR FOR THE DURATION OF THE EVENT AND ALL ALCOHOLIC BEVERAGES MUST BE REMOVED FROM THE PREMISES BEFORE RELEASING THE SECURITY GUARD FROM DUTY.
7. GLASS CONTAINERS. ALL GLASS CONTAINERS ARE PROHIBITED IN THE PARK EXCEPT FOR FOOD SERVING DISHES AT AN ORGANIZED EVENT AT THE PAVILION.
8. HORSES. ALL HORSES ARE PROHIBITED IN THE CITY PARK EXCEPT BY CITY PERMIT FOR ORGANIZED EVENTS.

9. LITTERING. LITTERING IS PROHIBITED.
10. PICNIC AREAS, TENNIS COURTS, AND GAME COURTS. PICNIC AREAS, TENNIS COURTS, AND GAME COURTS ARE AVAILABLE ON A FIRST COME FIRST SERVED BASIS EXCEPT WHEN THEY HAVE BEEN RESERVED IN ADVANCE FOR ORGANIZED GROUP ACTIVITIES. THERE WILL BE A CHARGE FOR USE OF LIGHTING. THESE FACILITIES CAN ONLY BE USED FOR THEIR DESIGNATED PURPOSE.
11. PAVILION. THE PAVILION SHALL BE USED BY CITY PERMIT. RESERVATIONS ARE ACCEPTED ON A FIRST COME, FIRST SERVED BASIS. SEE RATE SCHEDULES ESTABLISHED BY THE PARKS COMMITTEE. PERMITS ARE TO BE PICKED UP FROM THE CITY HALL DURING OFFICE HOURS, 7:30 A.M. TO 4:30 P.M., MONDAY THROUGH FRIDAY.
12. BASEBALL FIELDS. ALL BASEBALL FIELDS SHALL BE USED BY CITY PERMIT. (NOT AVAILABLE DURING BASEBALL SEASON.)
13. WALKING TRAILS. WALKING TRAILS ARE FOR WALKING OR JOGGING ONLY. BICYCLES, ROLLER BLADES, ROLLER SKATES, AND SKATEBOARDS ARE PROHIBITED.
14. CONCESSION CONCRETE AREAS. NO BICYCLES, ROLLER BLADES, ROLLER SKATES, OR SKATEBOARD ARE PERMITTED.
15. GOLF. NO PERSON SHALL HIT ANY GOLF BALL IN THE PARK.
16. RESPONSIBILITY FOR MINOR CHILDREN. IT IS AN OFFENSE TO PERMIT A CHILD OR WARD TO VIOLATE ANY RULE OR REGULATION OF THE CITY PARK WHEN SUCH CHILD OR WARD IS 17 YEARS OF AGE OR UNDER.
17. GAMBLING AND LEWD BEHAVIOR. NO PERSON SHALL GAMBLE OR PERFORM ANY ACT WHICH BY CONTEMPORARY STANDARDS MAY BE CONSIDERED LEWD, INDECENT OR IMPROPER IN OR UPON THE CITY PARK.
18. SOLICITING. SOLICITING FUNDS OR DONATIONS OF ANY ITEM OR OFFER TO SELL ANY GOODS, WARES, MERCHANDISE, LIQUID OR EDIBLE OR RENDER SERVICE FOR HIRE OR DISTRIBUTE WRITTEN MATERIALS IN THE PARK IS PROHIBITED EXCEPT BY THE AUTHORITY OF A CONCESSION AGREEMENT WITH THE CITY OF JEWETT.

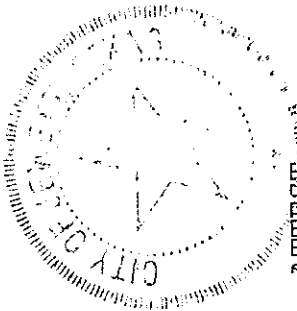
SECTION 2. PENALTY.

1. CRIMINAL PENALTY. A PERSON VIOLATING ANY OF THE PROVISIONS OF THIS ORDINANCE IS GUILTY OF A MISDEMEANOR, AND ON CONVICTION SHALL BE PUNISHED BY A FINE OF NOT LESS THAN \$1,000, OR CONFINEMENT IN JAIL FOR NOT MORE THAN 30 DAYS,

OR BY BOTH. EACH DAY OF CONTINUED VIOLATION OF ANY PROVISION OF THIS ORDINANCE CONSTITUTES A SEPARATE OFFENSE FOR WHICH THE OFFENDER MAY BE PUNISHED.

- 2. EXCEPTIONS. ALL CITY EMPLOYEES, CERTIFIED PEACE OFFICERS, LEON LITTLE LEAGUE VOLUNTEERS OR CONTRACTORS OF THE CITY ARE EXEMPT FROM THESE RULES WHEN ENGAGED IN PERFORMING THEIR PRESCRIBED OR ASSIGNED DUTIES.

THIS ORDINANCE IS TO BECOME EFFECTIVE THE 1st DAY OF August, 1998. PASSED AND APPROVED THIS 20th DAY OF July, 1998.

PAVILION RENTAL RATES:

DAY USE: \$25.00

NIGHT USE: \$35.00 (\$10.00 ADDITIONAL ELECTRICITY FOR NIGHT USE.

DEPOSIT: \$100.00 CLEAN UP DEPOSIT REQUIRED.

BASEBALL FIELD RENTAL AREAS:

FIELD 1 & 2 - \$100.00 PER DAY EACH.

FIELD 3 - \$25.00 PER DAY

PLUS ADDITIONAL CHARGE FOR ELECTRICITY USED FOR LIGHTING.

DEPOSIT - \$100.00 CLEAN UP DEPOSIT REQUIRED.
