**RESOLUTION AUTHORIZING
REDEMPTION OF OBLIGATIONS**

THE STATE OF TEXAS §

WHEREAS, the City of Jewett, Texas (the "City") has duly issued and there is now outstanding the following obligations:

City of Jewett, Texas General Obligation Sewer Bonds, Series 1978 dated April 1, 1978 currently outstanding in the aggregate principal amount of \$30,000 maturing on July 1 of the years 1999 through 2011 (the "Series 1978 General Obligation Sewer Bonds");

WHEREAS, the City Council of the City deems it to be in the best interest of the City to use lawfully available funds to redeem the above mentioned obligations on July 1, 1999.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF JEWETT, TEXAS:

Section 1. The City hereby calls for redemption the above-described obligations on July 1, 1999. Attached to this Ordinance as Exhibit "A" and made a part hereof for all purposes, is a copy of the notice of redemption for the obligations in substantially final form. The City Secretary and Bond Counsel are hereby authorized to (i) send notice to the Paying Agent/Registrar, (ii) send notice to the Farmers Home Administration and GMAC Commercial Mortgage, the current owners, respectively, of the obligations, (iii) publish the notices as required by the Ordinance authorizing the issuance of the obligations and (iv) to take all actions necessary to effectuate the redemption of the obligations including publishing notice as required by the ordinance authorizing the obligations.

Section 2. The City Secretary is hereby authorized to transfer funds as necessary to redeem the obligations set forth in Exhibit "A".

Section 3. The Mayor and the City Secretary are hereby authorized and directed to execute the certificate to which this Resolution is attached on behalf of the City and are further authorized to do any and all things proper and necessary to carry out the intent of this Resolution.

NOTICE IS HEREBY GIVEN that the City of Jewett, Texas ("City") has called for redemption the following obligations of the City (the "Bonds"):

City of Jewett, Texas Certificates of Obligation, Series 1978, maturing on July 1 in the years 1999 through 2011 in the aggregate principal amount of \$30,000; redemption date: July 1, 1999; redeemable at par plus accrued interest at the designated office for payment of the State Bank of Jewett, Texas, at the address set forth below, only upon presentation and surrender thereof. The described Certificates shall become due and payable on the redemption date specified, and the interest thereon shall cease to accrue from and after the redemption date of July 1, 1999.

In compliance with section 3406 of the Internal Revenue Code of 1986, as amended, payors making certain payments due on debt securities may be obligated to deduct and withhold 20% (31% for taxable years beginning in and after 1993) of such payment from the remittance to any payee who has failed to provide such payor with a valid taxpayer identification number. To avoid the imposition of this withholding tax, such payees should submit a certified taxpayer identification number when surrendering the Bonds for redemption.
