

CITY PART BASEBALL FIELD USAGE AGREEMENT BETWEEN  
THE CITY OF JEWETT AND THE LEON YOUTH BASEBALL/SOFTBALL  
ASSOCIATION

THIS AGREEMENT BETWEEN THE CITY OF JEWETT AND THE LEON YOUTH BASEBALL/SOFTBALL ASSOCIATION, HERINAFTER REFERRED TO AS LEON LITTLE LEAGUE, IS A PLEDGE BY THE CITY OF JEWETT TO MAKE AVAILABLE A PERMIT TO THE LEON LITTLE LEAGUE FOR AN APPROXIMATE FOUR-MONTH PERIOD (LITTLE LEAGUE BASEBALL SEASON) TO HAVE EXCLUSIVE USE OF ALL THREE BASEBALL FIELDS AND CONCESSION STAND IN THE CITY PARK.

FOR THE DURATION OF THIS PERMIT THE LEON LITTLE LEAGUE AGREES TO THE FOLLOWING:

1. TO BE RESPONSIBLE FOR THE SCHEDULING AND OPERATION OF ALL THREE BASEBALL FIELDS AND TO PROVIDE THE CITY WITH A SCHEDULE.
2. TO CONTROL, OPERATE, CLEAN AND MAINTAIN THE CONCESSION STAND AND RESTROOMS, INCLUDING KEEPING RESTROOMS SUPPLIED WITH TOILET PAPER AND TOWELS.
3. TO MOW, WEED EAT AND KEEP LITTER PICKED UP IN THE AREAS AS DESCRIBED. LITTER SHALL BE PICKED UP AT THE END OF THE EVENING AFTER GAMES OR PRACTICE AND PLACED IN THE DUMPSTER.
  - A. FIELDS 1 & 2 INSIDE AND OUTSIDE THE FENCE TO THE WALKING TRAIL AND PARKING LOT.
  - B. FIELD 3 INSIDE AND OUTSIDE THE FENCE AN APPROXIMATE 10 FOOT AND TO THE PARKING LOT ON THE WEST SIDE.
  - C. AREAS BETWEEN ALL THREE BALL FIELDS AND CONCESSION STAND.
4. TO PAY FOR ELECTRICITY USED TO LIGHT THE BALL FIELDS, ~~PARKING LOT, CONCESSION STAND AND RESTROOMS.~~

THIS AGREEMENT BETWEEN THE CITY OF JEWETT AND THE LEON YOUTH BASEBALL/SOFTBALL ASSOCIATION, HEREAFTER REFERRED TO AS LEON LITTLE LEAGUE, IS A PLEDGE BY THE CITY OF JEWETT TO MAKE AVAILABLE A PERMIT TO THE LEON LITTLE LEAGUE FOR AN APPROXIMATE FOUR-MONTH PERIOD (LITTLE LEAGUE BASEBALL SEASON) TO HAVE EXCLUSIVE USE OF ALL THREE BASEBALL FIELDS AND CONCESSION STAND IN THE CITY PARK.


FOR THE DURATION OF THIS PERMIT, THE LEON LITTLE LEAGUE AGREES TO THE FOLLOWING:

1. TO BE RESPONSIBLE FOR THE SCHEDULING AND OPERATION OF ALL THREE BASEBALL FIELDS.
2. TO CONTROL, OPERATE, CLEAN AND MAINTAIN THE CONCESSION STAND AND RESTROOMS, INCLUDING KEEPING RESTROOMS SUPPLIED WITH TOILET PAPER AND TOWELS.
3. TO MOW, WEED/EAT, AND KEEP LITTER PICKED UP IN THE AREAS AS DESCRIBED:
  - A. FIELDS 1 & 2 INSIDE AND OUTSIDE THE FENCE TO THE WALKING TRAIL AND PARKING LOT.
  - B. FIELD 3 INSIDE AND OUTSIDE THE FENCE AN APPROXIMATE 10 FOOT AND TO THE PARKING LOT ON THE WEST SIDE.
  - C. AREAS BETWEEN ALL THREE BALL FIELDS AND CONCESSION STAND.
4. TO PAY FOR ELECTRICITY USED TO LIGHT THE BALL FIELDS, PARKING LOT, CONCESSION STAND AND RESTROOMS.

THE LEON LITTLE LEAGUE FURTHER AGREES TO KEEP THE GRASS MOWED INSIDE THE FENCE ON ALL THREE BALLFIELDS FOR THE REMAINDER OF THE YEAR.
